STATUS UPDATE TRANSFERRING AGREEMENT

On July 21, 2020, the Commission issued an Order Approving Compliance Agreement (Agreement) in this docket.¹ The Agreement provides that it, in its entirety, may be transferable between operators only by an Order of the Commission approving the transfer.² Staff will file a status update in the docket created for this matter containing a recommendation regarding any proposed transfer between operators and will place an order regarding the transfer on the next available Consent Agenda for Commission consideration and possible approval.³

On June 20, 2024, a Request for Change of Operator (T-1) forms were submitted to transfer wells on the Thrall leases from Jim Snyder, Inc. (Operator) to Warhorse Petroleum, Inc. (Warhorse). The T-1 forms include all five wells that remain out of compliance with Operator's Agreement. Commission Staff recommends that the compliance agreement, in its entirety, be transferred from Operator to Warhorse. Warhorse has its own Commission approved compliance agreement in Docket 22-CONS-3008-CMSC and has demonstrated its ability to maintain compliance with that agreement.
