## MOTION FOR EXTENSION OF TIME TO FILE DIRECT TESTIMONY

- 1. On August 2, 2018, the Commission issued its order establishing the procedural schedule for this matter.
- 2. As set forth in the scheduling order, direct testimony of intervenors is due on October 29, 2018.
  - 3. On October 10, 2018, the Commission granted the intervention of KFB and KCGA.
- 4. KFB and KCGA have worked and continue to work diligently with a private consultant to develop and file written testimony.
- 5. Due to the short time between their intervention and the direct testimony due date, along with the timeframe set for responses to information requests, intervenors KFB and KCGA move for the Commission to allow them three more days, until Thursday, November 1, 2018, for the filing of their direct testimony.
