STATUS UPDATE ADDING WELLS TO COMPLIANCE AGREEMENT

On April 11, 2023, the Commission issued an *Order Granting Motion to Approve Amended Compliance Agreement* (Amended Agreement) in this docket. The Amended Agreement addressed 81 wells, requiring Operator to obtain compliance at four wells per quarter beginning June 30, 2023.¹ To date, Operator has brought 22 wells into compliance with the terms of the Amended Agreement. The Amended Agreement provides that it may be amended to include additional wells with the written consent of the District Supervisor.²

The District #3 Supervisor consents to adding the attached list of 50 wells (Subject Wells) to the Amended Agreement. Operator has indicated it is not opposed to the addition of the Subject Wells to the Amended Agreement. Further, the final compliance deadline is extended to June 30, 3031.
