NOTICE OF POSSIBLE EX PARTE COMMUNICATION

1. Occidental Chemical Corporation (OXY) scheduled separate meetings with Chairman Sievers and Commissioner Wright on Tuesday, June 5, 2012. The purpose of the meetings was to "Meet and Greet" the Commissioners, because OXY plans to become more active in Commission dockets.


2. OXY has recently been granted intervention in three Commission dockets: 12-WSEE-651-TAR, 12-WSEE-652-TAR, and 12-KG&E-718-CON.

3. During its meetings with Chairman Sievers and Commissioner Wright, OXY expressed concerns with escalating electricity costs at their Wichita plant. No written communications were provided.

4. OXY did not request any action from the Commission or make inappropriate statements about any open docket before the Commission. However, to the extent that OXY's concerns with Westar's rates may be somehow relevant to an open docket, Advisory Counsel, out of an abundance of caution, is giving notice of the communication, pursuant to K.S.A. 77-545(b) and K.A.R. 82-1-207.

5. All parties to the above-captioned dockets are informed of the communication and are afforded a reasonable opportunity to respond. K.A.R. 82-1-207.
