#### **APPLICATION**

COMES NOW Beren Corporation ("Operator") in support of its Application in the captioned matter states as follows:

- 1. Operator is a corporation authorized to do business in the State of Kansas. Operator's address is 2020 N. Bramblewood, Wichita, Kansas 67206.
- 2. Operator has been issued by the Kansas Corporation Commission Operator's License #5364, which expires on June 30, 2025.
- 3. Operator is the owner and operator of the Lois B #2 well, API #15-007-20726 ("the subject well"), which it located in the NE NW of Section 9, Township 35 South, Range 12 West, Barber County, Kansas. The subject well is located on an active oil and gas lease comprising the following lands:

Lois B Lease – East half of the Northwest quarter of Section 9, Township 35S, Range 12 West, Barber County, Kansas, containing 80 acres, more or less ("leased premises").

- 4. Pursuant to K.A.R. 82-3-111, Operator obtained temporary abandonment status for the subject well in January, 2015. The subject well has maintained such status from that date to the present date. Operator seeks such an exception.
- 5. On or about December 24th, 2024, the Kansas Corporation Commission notified Operator that temporary abandonment status for the subject well would be denied because the subject well had been temporarily abandoned for more than ten (10) years.
- 7. The subject well has demonstrated mechanical integrity, as evidenced by passage of a mechanical integrity test done March 27, 2025, which was witnessed by a member of the Kansas Corporation Commission staff.
- 8. Operator is holding the subject well for a workover fracking the Mississippi formation. Estimated cost to frack Lois B #2 is \$75,000. Estimated cost to plug and abandon the subject well is \$25,000. Estimated reserves of workover are 15 MBO and 125 MMCF of gas.
- 9. Operator has included a plat map showing the locations of all producing, injection, temporarily abandoned, abandoned, and plugged wells located on the same leased premises as the subject well. The Lois B lease contains 2 active wells, 1 injector and 1 producer. The lease makes 1 BOPD and 12 MCFD.
- 11. Listed in the attached Exhibit "A" are the names and addresses of the following persons:
  - A. Each operator of each oil and gas lease covering lands within one-half (1/2) mile radius of the subject well; and
  - B. Each person who owns any mineral interest of record in and under any lands located within one-half (1/2) mile radius of the subject well (provided that such mineral interest is not covered by any oil and gas lease).

12. Notice of this application will be published pursuant to K.A.R. 82-3-135a. In addition, notice of the hearing to be held in this matter will be provided as prescribed by K.A.R. 82-3-135.

WHEREFORE, Operator prays that this matter be set for hearing, and upon hearing, that

the Commission grant Operator's request for an exception to the 10-year limitation during which

well may be temporarily abandoned pursuant to K.A.R. 82-3-111 so as to allow the subject well

to remain temporarily abandoned for three (3) years following the expiration of the 10-year

limitation, subject to yearly renewal with the appropriate Conservation Division District, but

without further need to re-apply for a new exception each of the three (3) years prayed for in this

application.


