PREHEARING OFFICER ORDER CANCELLING STATUS CONFERENCE

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having reviewed the pleadings and record, the Prehearing Officer makes the following findings:

1. On December 7, 2017, the Commission designated a Prehearing Officer to address any scheduling or procedural matters pursuant to K.S.A. 77-517(b).¹
2. On January 5, 2018, at the Prehearing Conference, the parties agreed to hold a Status Conference on Friday, March 2, 2018 at 10:00 a.m., in the hopes of resolving the outstanding issues involved in this proceeding.
3. On February 9, 2018, Staff filed a Motion to Rescind Order Denying Application for License. Therefore, the Parties do not wish to hold the scheduled status conference.

THEREFORE, THE PREHEARING OFFICER ORDERS:

- A. The Status Conference set for Friday, March 2, 2018, at 10:00 a.m. is cancelled.
- B. Parties have 15 days from the date of electronic service of this Order to petition for reconsideration.²
