## ORDER GRANTING JOINT MOTION TO EXTEND STATUTORY DEADLINE

This matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and decision. Having reviewed the pleadings and record, the Commission makes the following findings and conclusions:

- 1. On February 14, 2020, Evergy Kansas Central, Inc. and Evergy Kansas South, Inc. (collectively Evergy Central) filed an application requesting approval from the Commission of certain tariff changes necessary to implement an integrated Customer Forward Program with Evergy Metro, Inc.<sup>1</sup>
- 2. On March 3, 2020, the Commission suspended the effective date of the application for 240 days, from February 14, 2020 until October 12, 2020.<sup>2</sup>
- 3. On September 2, 2020, Evergy Central filed supplemental information as requested by Commission Staff (Staff).<sup>3</sup>
- 4. On September 8, 2020, Evergy Central and Staff filed a joint motion requesting a 30-day extension of the K.S.A. 66-117(c) statutory deadline. The parties state the extension is

necessary due to disruptions caused by the COVID-19 pandemic, including the temporary State shutdown and the Commission's Emergency Order Staying All Dockets.<sup>4</sup> The parties further state an extension is necessary to allow Staff time to thoroughly investigate Evergy Central's application and supplemental information, and to issue its recommendation. The parties request a new deadline

to Wednesday, November 11, 2020.<sup>5</sup>

5. K.S.A. 66-117(c)(3) provides, "nothing in this subsection shall preclude the public

utility or common carrier and the commission from agreeing to a waiver or an extension of the

240-day period." The Commission accepts Evergy Central's agreement to extend the deadline for

a Commission order in this docket to November 11, 2020. Accordingly the Commission grants the

Joint Motion to Extend Statutory Deadline.

THEREFORE, THE COMMISSION ORDERS:

A. The Joint Motion to Extend Statutory Deadline is granted. The Commission's Order

in this docket is due no later than November 11, 2020.
