MOTION FOR CONTINUANCE OF PROCEDURAL DEADLINES AND EVIDENTIARY HEARING

Commission Staff (Staff) of the State Corporation Commission of the State of Kansas (Commission) files this Motion for a continuance of the procedural deadlines and the evidentiary hearing in this docket. In support of its Motion, Staff states as follows:

- 1. On August 22, 2017, Operator was penalized. On September 25, 2017, Operator timely requested a hearing. On November 15, 2017, the prehearing officer issued an order setting a procedural schedule. Staff's testimony is due today, January 22, 2018; Operator's is due January 29; rebuttal is due February 5; and the evidentiary hearing is scheduled for February 15.
- 2. Staff and Operator are in the midst of settlement negotiations. Staff believes this matter may be able to be resolved without the need for an evidentiary hearing. Staff believes a continuance would assist in settlement, and Operator is not opposed.
- 3. Accordingly, Staff requests a continuance of the procedural deadlines so that Staff's testimony will be due February 19; Operator's due February 26; rebuttal due March 5; and the evidentiary hearing scheduled for March 15, 2018.

WHEREFORE, Staff requests this motion be granted.


