

Each year Atmos Energy files a report showing the calculation of its Weather Normalization Adjustment Factor (WNAF). The purpose of the factor is to adjust the company's revenues to normal weather conditions – that is, to remove the effects of non-normal weather from delivery charges. The commission approved Atmos' WNAF in Docket 03-ATMG-539-TAR. As agreed to in that docket, Atmos provides commission staff with their data and calculations by July 15th. Commission staff carries out a review process and reports to the commission.

This year, Atmos filed their new WNAF on July 15th. Staff has reviewed Atmos' factor and a couple of items should be noted. During staff's review, Atmos made a change in their WNAF calculations due to an error in weather data for one station. The initial factor Atmos filed was for a refund to customers of \$0.00258 per Ccf. The change in weather data resulted in a factor of \$0.00260 per Ccf. Atmos has re-filed its corrected calculations. In addition, it was determined that Section VI of the Atmos Tariff – the section outlining calculation of the WNAF – was not filed after Atmos' 2010 rate case (10-ATMG-495-RTS). Following the rate case, changes were made to the calculation procedures, and the temperature sensitivity coefficients were changed to those estimated by commission staff member Michael Mount in his weather normalization procedures. Staff made arrangements with Atmos to have them file Section VI of their Tariff before staff would recommend the 2011/2012 factor. Atmos complied with staff's request, and Section VI is now on file.

Staff has examined Atmos' data and calculations, and staff believes the \$0.00260 per Ccf refund to customers is correct. This factor represents an over-collection in the amount of \$281,837 due to temperature conditions during the 2010/2011 season. The new factor will be billed over the 12-month period beginning August 2011.
