ORDER SETTING PROCEDURAL SCHEDULE

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having reviewed its files and records, and being fully advised in the premises, the Commission makes the following findings:

1. On April 23, 2018, Prairie Land Electric Cooperative, Inc. (Prairie Land) filed with the Commission an Application requesting approval to update its Local Access Delivery Service (LADS) tariff.¹ The Application was filed pursuant to Prairie Land’s 34.5kV Formula Based Rate (FBR) Plan approved in Docket No. 16-MKEE-023-TAR.²

2. On April 25, 2018, William G. Riggins entered his appearance on behalf of Kansas Electric Power Cooperative, Inc. (KEPCo).

3. On May 17, 2018, Prairie Land, KEPCo, and Commission Utilities Staff (Staff) (collectively, Joint Movants) filed a Joint Motion for Procedural Schedule, recommending an agreed schedule to the Commission for its review and approval.³ Having reviewed the Joint Motion, the Commission adopts the following schedule:

Staff/Intervenor questions submitted to Prairie Land	10 days prior to Technical Conference
Technical Conference, if necessary (9:00 a.m. start time)	June 28, 2018
Status Conference Call (10:00 a.m. start time)	August 15, 2018
Staff/Intervenor Report and Recommendation or Testimony	August 21, 2018
Prairie Land Rebuttal Testimony, if necessary	September 5, 2018
Commission Order (either approving the rate adjustment based upon the paper record or notifying the parties that an evidentiary hearing will be held)	September 20, 2018
Evidentiary hearing, if necessary (9:00 a.m. start time)	September 26, 2018
Commission Order, if Evidentiary Hearing	October 22, 2018 (October 20 falls on a Saturday, and the next Commission business meeting is October 23.

THEREFORE, THE COMMISSION ORDERS:

- A. The procedural schedule in paragraph 3 above is adopted.
- B. Any party may file and serve a petition for reconsideration pursuant to the requirements and time limits established by K.S.A. 77-529(a)(1).⁴
- D. The Commission retains jurisdiction over the subject matter and parties for the purpose of entering further orders as it deems necessary.
