## Section 3. LOCAL SERVICE

## 3.1 Local Access Service

These monthly rates apply to all subscribers of the company. This rate covers the provision of network access to a local customer location, and entities the customer to local calls (without toll charge) to all local stations connected to the central office. Extended area service to Craw-Kan Telephone Cooperative Association exchanges at Columbus, Hallowell, Weir, West Mineral, and Crestline and to the Embarq Telephone Company at Scammon is without charge.

When any city imposes a franchise, occupation, business, sales, license, excise, privilege or similar tax of any kind on this company, the amount thereof, insofar as practical, shall be charged on a proportionate basis to all subscribers receiving telephone service within the boundaries of such city. This tax charge, in all cases, will be in addition to the regular charges for telephone service.

All such taxes so imposed on this Company shall be billed periodically to each main station in proportion to the total tax divided by the number of main stations. Such billing shall start on the regular monthly bill in the month preceding that month in which the tax is payable to the city and shall continue at a rate not to exceed the rate of \$1.00 per month per main station until the said proportionate share is paid. The pro rata tax applicable to each subscriber will appear on the regular subscriber statement identified as such.

The company will assess a fee for funding of the Kansas Universal Service Fund (KUSF), including Kansas Lifeline Service Program (KLSP), and the Kansas Telecommunications Access Program (TAP). These funds were enacted by the Kansas Legislature in 1996, and authorized by the Kansas Corporation Commission on December 27, 1996 in Docket number 190,492-U. The amount of the fee may vary as determined by the fund administrator.
