The above-captioned matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and determination. Having examined its files and record, and being duly advised in the premises, the Commission finds and concludes as follows.

1. On July 9, 2013, the Commission issued an Order adopting the March 5, 2013 Audit Report and Recommendations of GVNW Consulting, Inc. (GVNW), which was filed in this matter on June 27, 2013. Ordering paragraph B of the July 9, 2013 Order directed Sprint Spectrum L.P. (Sprint) to refund to its current customers the sum of \$107,015.08 by means of one-time bill credits. Upon completion of the refund, Sprint was further directed to provide GVNW with an affidavit executed by an officer of the company attesting to completion of the refund and also provide GVNW with copies of customer bills substantiating issuance of the refunds. Ordering paragraph F of the July 9, 2013 Order provided that upon Sprint's completion of the foregoing requirements, GVNW was to submit an update to the Commission acknowledging the company's compliance, whereupon this docket would be closed.

2. On August 5, 2013, GVNW filed an Update dated August 1, 2013, verifying that Sprint had completed the required refund to customers and provided the required affidavit attesting to completion of the refund, as well as the required customer bills substantiating the refund. Sprint having fully complied with the requirements of ordering paragraph B of the Commission's July 9, 2013 Order, the Commission finds that this docket should be closed.

IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:

A. GVNW Consulting, Inc. and Sprint Spectrum L.P. have fully satisfied the requirements of ordering paragraphs B and F of the Commission's July 9, 2013 Order and this docket is hereby closed.

B. The Commission retains jurisdiction over Sprint Spectrum L.P. and the subject matter of this docket for the purpose of issuing such additional orders as it deems necessary.
