Communications.

BACKGROUND:

On July 3, 2007 Southwestern Bell Telephone Company filed an application for approval of a modification to the Interconnection Agreement previously approved between Southwestern Bell Telephone, L.P d/b/a AT&T Kansas ("AT&T Kansas") and Logix Communications, LP d/b/a Logix Communications ("Logix").

ANALYSIS:

This modification to the agreement is consistent with the provisions of Section 252(e) of the Federal Act and amends, modifies and supersedes the agreement previously negotiated, executed and filed with the Commission on May 2, 2006. This amendment amends the Agreement to extend the original expiration date to December 12, 2011. The previous expiration data was set for December 12, 2008. Except as modified herein, all other terms and conditions of the underlying agreement remains unchanged and in full force.

On August 28, 2002, in Docket No. 03-WSNC-105-COC, the Commission granted Western Communications, Inc. d/b/a Logix Communications, LP a certificate of convenience and authority to provide Inter-exchange telecommunication services (interconnection reseller) in the state of Kansas.

On September 4, 2002, in Docket No. 03-WSNT-106-COC, the Commission granted Western Communications, Inc. d/b/a Logix Communications, LP a certificate of convenience and authority to provide local telecommunications services (CLEC) in the state of Kansas.

On April 3, 2006, in Docket Nos. 06-WSNT-883-CCN and 06-WSNC-885-CCN, the commission granted Western Communications a name change to Logix Communications, LP.

Logix Communications, LP is registered with the Kansas Secretary of State's office and is currently "active and in good standing."

Staff has reviewed this modification to this Interconnection Agreement between Southwestern Bell Telephone Company and Logix Communications, and finds no evidence to conclude this agreement discriminates against any telecommunications carrier, nor is inconsistent with public interest, convenience and necessity. Staff does not have any concerns with approving this application.

RECOMMENDATION:

Staff recommends the Commission grant approval for a modification to the Interconnection Agreement between Southwestern Bell Telephone Company and Logix Communications.
