**PREHEARING OFFICER ORDER RESCHEDULING PREHEARING CONFERENCE**

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having reviewed the pleadings and record, the Prehearing Officer makes the following findings:

1. On August 22, 2017, the Commission issued its *Order to Show Cause, Designating a Prehearing Officer, and Setting a Prehearing Conference* (Order), scheduling a Prehearing Conference for September 14, 2017.<sup>1</sup>

2. On September 11, 2017, Commission Conservation Staff (Staff) filed a Motion to Reschedule Prehearing Conference, stating that, due to a scheduling conflict for H & H Production, Inc. (Operator), "[t]he parties jointly request that the pre-hearing conference in this docket, currently scheduled for September 14, 2017, at 1:30 pm be rescheduled to mid-late October 2017."<sup>2</sup>

3. On September 14, 2017, the Commission issued its *Order Rescheduling Prehearing Conference*, setting a Prehearing Conference for October 26, 2017.<sup>3</sup>

4. On October 4, 2017, Staff asked that the Prehearing Conference again be continued due to the unavailability of counsel.<sup>4</sup> The Operator agreed to the continuance.

5. On November 9, 2017, the parties again agreed to continue the Prehearing Conference for 60 days to provide the Operator time to work on plugging the wells at issue.

**THEREFORE, THE PREHEARING OFFICER ORDERS:**

A. The Prehearing Conference is rescheduled for Thursday, **January 11, 2018, at 9:30 a.m.** by telephone. The conference information is: telephone number (866) 620-7326, Conference Code PIN: 7632914771#.

B. Any party that fails to attend or participate in the status conference, hearing, or other stage of this proceeding may be held in default pursuant to the KAPA.<sup>5</sup>

C. The parties have fifteen (15) days, plus three (3) days if mailed service, from the date this Order was served in which to petition for reconsideration.<sup>6</sup>

D. The Commission retains jurisdiction over the subject matter and parties for the purpose of entering such further orders as it deems necessary.
