 - c. Any settlement agreement that the parties wish to present for the Commission's consideration shall be due by December 5, 2016.

- d. Any person requiring special accommodations under the Americans with Disabilities Act is asked to give notice to the Commission at least 10 days prior to the scheduled hearing date.


