There was service there until a few years ago because Evergy did not want to maintain the electric line, and is now stating is they discontinued it because of liability concerns (This is a load of Buffalo Bagels) Its all about maintenance costs to maintain it. This is a company that pays their CEO millions and is worth millions wanting to extract \$4300.00 from a daughter that is homeless and a 15 yr old child and a 80yr old retiree. We do not have \$3400 to pay the extra costs. Evergy has allowed 17,000 for the construction of a new power line. Evergy is now stating that this is a new service, which of course it is not technically not. Not matter what happens with this issue, it is just plain wrong, there are no doubt hundreds of folks that have had the same experience.
