ORDER GRANTING ADMISSION TO BRANDON M. DITTMAN *PRO HAC VICE*

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having examined its files and records, and being fully advised in the premises, the Commission finds and concludes as follows:

1. On June 29, 2018, Kansas Gas Service (KGS) filed for a \$45.6 million revenue increase.¹ KGS also seeks to allocate savings from prefunded pension expenses with one-third going to customers and two-thirds to its shareholders.² In addition, KGS is proposing a Revenue Normalization Adjustment to sever the link between its revenue and customer usage, a cybersecurity O&M expense tracker, and a depreciation tracker.³

2. On October 4, 2018, John F. Wilcox, Jr., an attorney in good standing and licensed to practice law in the State of Kansas, filed a Motion to admit Brandon M. Dittman *Pro Hac Vice*⁴ as an attorney on behalf of WoodRiver Energy, LLC (WoodRiver), pursuant to Kansas Supreme Court Rule 116 (Motion). Mr. Wilcox stated he will sign all pleadings and

other papers which are filed before the Commission and will be actively engaged in the case and present for all appearance[s], as the Commission may require.⁵

3. The Motion included the required verified application signed by Mr. Dittman, pursuant to Supreme Court Rule 116(e).⁶ Mr. Dittman has verified he is in good standing and licensed to practice law as a member of the Colorado and New Jersey Bars. Mr. Dittman is not currently, and never has been, the subject of public discipline, including suspension or disbarment, in any jurisdiction.⁷ The verified petition lists Mr. Dittman's business address as: Kissinger & Fellman, P.C., 3773 Cherry Creek N. Drive, Ptarmigan Place, Suite 900, Denver, Colorado 80209.

4. The Commission finds Mr. Dittman has met the requirements of Supreme Court Rule 116 and shall be granted admission *pro hac vice* to appear on behalf of WoodRiver in this docket. Mr. Dittman will be added to the mailing list, and electronic service of pleadings, communications and correspondence should be delivered as follows:
