# NOTICE REGARDING APPLICATION FOR DESIGNATION AS AN ELIGIBLE TELECOMMUNICATIONS CARRIER ON A WIRELESS BASIS

COMES NOW Boomerang Wireless, LLC ("Boomerang" or the "Company") by and through its undersigned counsel, and submits this Notice that it no longer seeks state universal service support for wireless Eligible Telecommunications Carrier ("ETC") services. In further support of this Notice, Boomerang states as follows:

- 1. On July 27, 2012, Boomerang filed its Application for Designation as an Eligible Telecommunications Carrier on a Wireless Basis in this docket, requesting that the State Corporation Commission of the State of Kansas ("Commission") designate it as a wireless ETC for only low-income support from the Federal Universal Service Fund ("FUSF") and Kansas Universal Service Fund ("KUSF") throughout the service area set forth in its Application.
- 2. After conferring with the Staff of the Commission, Boomerang understands that Kansas does not allow state low-income universal service support for carriers that do not have their own facilities in Kansas. Boomerang therefore notifies the Commission that it no longer seeks support from the KUSF.

WHEREFORE Boomerang Wireless, LLC respectfully notifies the Commission that it no longer seeks Kansas Universal Service Fund support for its wireless services and requests that the Commission designate Boomerang Wireless, LLC as an ETC for only low-income support from the Federal Universal Service Fund.
