

You, and each of you, are hereby notified that Double "D" Oil Company, Inc. has filed an application to commence the injection of saltwater into the Bartlesville formation at the Howard Moon #1 well located in the NW SW NW of Section 21-32S-5E, Cowley County, Kansas, with a maximum operating pressure of 0 psi and a maximum injection rate of 500 bbls per day.

Any persons who object to or protest this application shall be required to file their objections of protest with the Conservation Division of the State Corporation Commission of the State of Kansas within 30 days from the date of this publication. These protests shall be filed pursuant to Commission regulations and must state specific reasons why granting the application may cause waste, violate correlative rights or pollute the natural resources of the State of Kansas.
