**STATUS UPDATE ADDING WELL TO COMPLIANCE AGREEMENT  
AND EXTENDING FINAL COMPLIANCE DEADLINE**

On April 10, 2025, the Commission issued an *Order Approving Compliance Agreement* (Agreement) in this docket. The Agreement requires Operator to bring three wells into compliance with K.A.R. 82-3-111 by bringing one well into compliance per quarter beginning June 30, 2025.<sup>1</sup> To date, Operator has brought one well into compliance with the Agreement. The Agreement provides that it may be amended to include additional wells with the written consent of the District Supervisor.<sup>2</sup>

The District #2 Supervisor consents to amending the Agreement to include the Mark #1, API #15-095-20812 (Subject Well). Operator has indicated it is not opposed to the addition of the Subject Well to the Agreement. Further, Staff recommends the final compliance deadline be extended to March 31, 2026.
