CONDITIONS COMPLIANCE FILING**






On March 19, 2012, the Commission granted Texas Kansas Oklahoma Gas, L.L.C. ("TKO") a Limited Certificate of Public Convenience and Authority, subject to the following conditions: (1) TKO shall provide a copy of all new or re-negotiated contracts by January 1 of each year; and (2) TKO shall file on an annual basis by January 1, a copy of an updated contract summary.

Due to the holiday season, counsel has been unable to confirm that the required compliance filings were made. In order to ensure that TKO remains in compliance with the Commission's order, we respectfully request a three-week extension, or until January 21, 2014, to confirm and/or submit TKO's 2013 Conditions Compliance Filing.

Thank you for your consideration of this request.

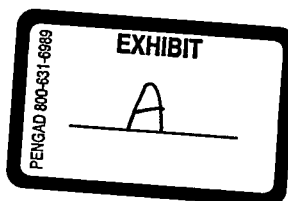
