PRESIDING OFFICER ORDER
DENYING MOTION FOR DEFAULT JUDGMENT
AND SETTING PREHEARING CONFERENCE

The Presiding Officer rules as follows:

1. On March 21, 2025, Operator filed an application as described by the above caption. On April 10, 2025, Twyla Hoobler Wagner, as Trustee of the Twyla Hoobler Wagner Trust (the Trust), submitted a protest and request for hearing.
2. On April 29, 2025, the Commission designated a presiding officer and set a May 15, 2025, prehearing conference. Operator failed to attend the prehearing conference.
3. On May 21, 2025, the Trust motioned for default judgment, seeking dismissal of Operator's application with prejudice. On June 2, 2025, Commission Staff filed a response, asking that any order dismissing the application be without prejudice, citing concerns that dismissal with prejudice could result in waste and negatively impact correlative rights.
4. Upon review, it appears that Operator was not served the April 29, 2025, Commission order setting the prehearing conference, was not served the Trust's motion for default judgment, and was not served Staff's response.
5. Accordingly, the motion for default judgment is denied. A prehearing conference is scheduled for **Thursday, June 26, 2025, at 3:30 p.m.** by telephone. The conference call

information is: telephone number (253) 205-0468, Meeting ID 5248125436.¹ All directives in the Commission's August 29, 2025, order continue to apply.

6. The Commission's docket room is directed provide a copy of the Commission's April 29, 2025, order to Mr. Gabel as part of its service of this order.
