**ORDER CANCELLING PROCEDURAL
SCHEDULE AND CLOSING DOCKET**

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having examined its files and records, and being fully advised in the premises, the Commission finds and concludes as follows:

1. On June 19, 2017, Commission Conservation Staff (Staff) issued a Notice of Denial of License Renewal Application to Black-Travis, Inc. (Operator).¹ Staff stated the Operator's license was denied on the basis of Staff's assertion that the Operator's application did not meet the requirements of K.S.A. 55-155.²
2. On July 5, 2017, the Operator filed a Request for Hearing.
3. On February 23, 2018, Staff filed a Motion to Cancel Procedural Schedule and Close Docket, noting that "Staff has approved Operator's application and has issued Operator's license."³
4. Given Staff's subsequent issuance of the Operator's license, the Commission finds that granting Staff's Motion is in the public interest.

THEREFORE, THE COMMISSION ORDERS:

A. Staff's Motion to Cancel the Procedural Schedule and Close the Docket is granted.

B. The parties have fifteen (15) days, plus three (3) days if mailed service, in which to petition the Commission for reconsideration.⁴

C. The Commission retains jurisdiction over the subject matter and the parties for the purpose of entering such orders as it may deem necessary.
