**PREHEARING OFFICER ORDER SETTING STATUS CONFERENCE**

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having reviewed the pleadings and record, the Prehearing Officer makes the following findings:

1. On February 7, 2020, Double "D" Oil Company, Inc. (Operator) filed an Application seeking authorization for injection of saltwater into the Howard Moon #1 well in Cowley County.
2. Between March 5, 2020, and March 13, 2020, Roger and Allyson Moon, Garth and Amy Moon, and George H. Moon filed protests.
3. At a June 4, 2020, prehearing conference, all parties present agreed to set a status conference for September 3, 2020, so that Operator may consider whether to further pursue its Application, and so that parties may have additional time to explore resolution of these matters absent the need for a procedural schedule.
