ORDER DESIGNATING PRESIDING OFFICER

This matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and decision. Having reviewed the pleadings and record, the Commission makes the following findings:

- 1. On February 11, 2025, Evergy Kansas Central, Inc. and Evergy Kansas South, Inc. (EKC) and Evergy Metro, Inc. d/b/a Evergy Kansas Metro (EKM) (EKC and EKM collectively referred to as Evergy) filed an Application seeking expedited approval of its Large Load Power Service (LLPS) Rate Plan, with a new tariffed rate offering for customers over 100 MW seeking to interconnect with Evergy. Evergy proposes to file annual compliance report filings with the Commission to track the success of the LLPS Rate Plan. Additionally, Evergy requests expediting ed an order by June 20, 2025.
- 2. The Commission may designate a presiding officer to conduct prehearing conferences to address any matters appropriately considered in a prehearing conference, including
