## MOTION FOR 1-DAY EXTENSION TO REBUTTAL TESTIMONY DEADLINE

Commission Staff (Staff) of the State Corporation Commission of the State of Kansas (Commission) files this Motion for a one-day extension to the rebuttal testimony deadline. In support of its Motion, Staff states as follows:

- 1. On June 15, 2017, the Commission issued a Penalty Order against Operator, who timely appealed. The matter has been set for a December 14, 2017, evidentiary hearing. Staff timely submitted direct pre-filed testimony on November 8, 2017, and Operator did so on Friday, November 17, 2017. Rebuttal testimony is due today, December 4, 2017.
- 2. Staff's counsel was on Commission-approved leave during Thanksgiving, from November 17, 2017 to Sunday, November 26, 2017. Unfortunately, one of Staff's chief rebuttal witnesses went on funeral leave beginning Monday, November 27, 2017, and is not scheduled to return until tomorrow, December 5, 2017. Staff cannot complete its rebuttal testimony without this witness, and therefore moves for a one-day extension to the deadline for submission of rebuttal testimony. Staff has consulted with Operator's counsel, who is not opposed.

WHEREFORE, Staff requests this motion for a one-day extension be granted.


