# PREHEARING OFFICER ORDER CANCELLING PREHEARING CONFERENCE AND CLOSING DOCKET

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having reviewed the pleadings and record, the Prehearing Officer makes the following findings:

- 1. On January 30, 2019, Hopper Oil Co., Inc. (Operator) filed an Application to amend injection permit E-17207, requesting to add the Hammer #10 well to the permit. Cindy Hoedel filed a protest of the Application.
  - 2. On March 15, 2018, Operator withdrew its Application.<sup>3</sup>
- 3. Based on Operator's withdrawal of its Application, the Prehearing Officer finds further proceedings are unnecessary.

#### THEREFORE, THE PREHEARING OFFICER ORDERS:

A. The prehearing conference in this docket, scheduled for this afternoon, is cancelled.<sup>4</sup>
