This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having reviewed the pleadings and record, the Prehearing Officer makes the following findings:

1. On October 4, 2018, the Commission issued a Penalty Order against Liberty Operations & Completions, Inc. (Operator), concluding the Operator committed one violation of K.A.R. 82-3-407 because a current and successful mechanical integrity test (MIT) had not been performed on the subject well.¹
