Under the terms of the Agreement, Liberty-Empire will file an Application with the Commission no later than February 5, 2020 setting forth in detail the impact the retirement of Asbury will have on the Company's Kansas revenue requirement and proposing a rate mechanism to flow through changes in the revenue requirement due to the retirement of Asbury.


