

4. On June 12, 2025, Ring filed a Motion for Extension of Time requesting the deadline be extended by sixty (60) days, to August 11, 2025, so that Ring and VPS can collaborate on the remedial actions. Staff does not oppose granting an extension.

5. K.A.R. 82-1-217(b) grants the Commission the ability to extend any deadline for good cause. Nothing in the record indicates that Ring's request is in bad faith or designed to unnecessarily delay compliance, therefore the Commission grants the Motion for Extension of Time. The Commission extends the deadline for Ring to take all corrective actions, as directed by the Commission's May 13, 2025, Order, to August 11, 2025.

IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:

A. Ring Central Inc.'s Motion for Extension of Time is granted. The deadline for Ring to take corrective actions as ordered in the Commission's May 13, 2025, Order, is extended to August 11, 2025.

B. Any party may file and serve a petition for reconsideration pursuant to the requirements and time limits established by K.S.A. 77-529(a)(1).¹
