**ORDER SETTING PREHEARING CONFERENCE**

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having examined its files and records, and being fully advised in the premises, the Commission finds the following:

1. On January 30, 2020, the Commission issued a final order in these consolidated dockets, affirming underlying penalty orders issued in February 2019. On March 3, 2020, the Commission denied Operator's petition for reconsideration. On March 9, 2020, Commission Staff suspended Operator's license for non-compliance with the Commission's orders in these dockets.<sup>1</sup>

2. On June 16, 2020, the Commission issued a Shut-In Order, directing Staff to shut-in Operator's oil and gas operations and assessing a \$10,000 penalty, due to Operator's failure to bring wells into compliance with K.A.R. 82-3-111 and failing to cease operations upon suspension of Operator's license. On July 14, 2020, Operator filed a request for hearing regarding the Shut-In Order.

3. A prehearing officer has already been designated in these dockets and shall continue to be Jonathan R. Myers, Assistant General Counsel, who shall have the same authorities as outlined previously. The Commission finds a prehearing conference should be scheduled.

**THEREFORE, THE COMMISSION ORDERS:**

The Commission may designate other Staff members to serve in this capacity. **The Commission directs electronic service of all filings in the docket to include service on the Presiding Officer and mailed service of all filings to be directed to the Presiding Officer's attention.**

B. A Prehearing Conference is scheduled for **Thursday, August 13, 2020, at 3:00 p.m.** by telephone. The conference call information is: telephone number (866) 620-7326, Conference Code PIN: 3902542751.

C. At the Prehearing Conference, parties shall be prepared to discuss deadlines for filing testimony and briefs, discovery procedures, scheduling of a hearing with the Commission, and any other issues that will promote the orderly and prompt resolution of this proceeding.

D. Filings shall be made with the Commission's Docket Room before 5:00 p.m. on the date scheduled for service. Any electronic service received after the deadline set forth in the procedural schedule, or any filing made after 5:00 p.m. on the date scheduled for service, shall be accompanied by a Motion to File Out-of-Time

E. At the Prehearing Conference, without further notice, this proceeding may be converted into a conference hearing or a summary proceeding for disposition of this matter as provided by the Kansas Administrative Procedure Act (KAPA). Any party that fails to attend or participate in the

Prehearing Conference, hearing, or other stage of this proceeding may be held in default under the KAPA.<sup>2</sup>
