Evidentiary Hearing before the Commission 266 N. Main, Suite 220, Wichita, Kansas 67202	October 27, 2016, 10:00 a.m.

2. Parties should note the following:
- Failure to submit pre-filed testimony will likely result in the Commission restricting the right to testify and present evidence at hearing.
 - At hearing, the Commission may limit direct and rebuttal testimony to the pre-filed testimony.
 - Any settlement agreement that the parties wish to present for the Commission's consideration shall be due by October 17, 2016.

- d. Any person requiring special accommodations under the Americans with Disabilities Act is asked to give notice to the Commission at least 10 days prior to the scheduled hearing date.
