**APPLICATION**

COMES NOW Applicant, Kansas Gas Service Company, a division of ONEOK, Inc. ("Kansas Gas Service") and files this request for the Kansas Corporation Commission ("Commission") to open a utility-specific docket for Kansas Gas Service to utilize in filing its monthly contract summary filings and its annual written report relating to supply and transportation contracts and purchasing practices. This Application is being filed in accordance with the Order issued by the Commission in KCC Docket No. 106,850-U (75-GIMC-009-GIG) on June 21, 2001. In support of this Application, Kansas Gas Service states as follows:

1. Kansas Gas Service is a division of ONEOK, Inc. Kansas Gas Service's principal place of business is located at 7421 West 129<sup>th</sup> Street, Overland Park, Kansas, 66213. Kansas Gas Service is a natural gas public utility subject to the jurisdiction of the Commission. Kansas Gas Service holds appropriate Certificates of Convenience and Authority issued by the Commission, which allows it to provide natural gas services to its customers in Kansas.

3. On June 21, 2001, the Commission issued an Order in Docket No. 106,850-U (75-GIMC-009-GIG). In that Order, the Commission ordered Kansas Gas Service and other natural gas utilities in the state to file with the Commission monthly contract summary filings and an annual written report relating to supply and transportation contracts and purchasing practices. The Order indicated that the filings should be made in utility-specific dockets.


5. Kansas Gas Service has conferred with the Staff of the Commission regarding the opening of a utility-specific docket pursuant to the Commission's June 21, 2001 Order, and the Staff has requested that the utility file this Application with the Commission.

6. The purpose of this Application is to request that the Commission open a utility-specific docket for Kansas Gas Service to utilize in filing its monthly contract summary filings and its annual written report relating to supply and transportation contracts and purchasing practices.

7. Kansas Gas Service is filing a Motion for Protective Order and Motion for Scheduling Conference simultaneously with the filing of this Application. The purpose of the Motion for Protective Order is to have the Commission establish guidelines regarding the review by parties of confidential information contained in the monthly contract summary filings and annual written report. The purpose of the Scheduling Conference is to establish a schedule for the annual meeting between Kansas Gas Service and the Staff of the Commission.

8. The granting of this Application and the motions filed herewith will allow Kansas Gas Service to meet the requirements established by the Commission in its June 21, 2001 Order, in an orderly and formal process.

WHEREFORE, Kansas Gas Service requests that its Application be granted.



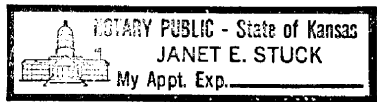
