PETITION FOR RECONSIDERATION

COMES NOW, Griffin Management, LLC ("Griffin"), by and through its consultant, files this Petition for Reconsideration ("Petition") requesting reconsideration of existing order pursuant to K.A.R. 77-529(a) authorizing the drilling of the Terese #1H as a horizontal wellbore in Barber County, Kansas. In support of its Petition, Griffin states as follows:

1. Griffin is a foreign limited liability company duly authorized by and in good standing with the Kansas Secretary of State's office to do business in the State of Kansas. Griffin's mailing address is PO Box 347, Barber, Kansas, 67124-0347.
2. The Commission has issued Griffin oil and gas Operator's License No 33936, which license is in full force and effect through March 30, 2018.
3. Griffin owns and operates oil and gas leases covering the following described tracts of land located in Barber County, Kansas, to-wit:

All of Section Eight (8), Township Thirty- two South (32), Range Twelve (12) West of the 6th P.M.,


(the 'Subject Land'). The oil and gas leases covering the Subject Land will be unitized by Griffin for the production of oil and gas prior to the drilling of the subject horizontal wellbore.

4. Griffin makes note of typographical error in listing the well location within the docket application. Due to Scribner's error in the Application for Horizontal Wellbore, Paragraph 5, and in Order Granting Application, Paragraph 6 and Paragraph 7, well location is listed as Section 8, Township 32 South, Range 12 West. Proper location of the Terese 1H well bore is Section 8, Township 33 South, Range 12 West.

5. Griffin properly served and published notice as required by K.A.R. 82-3-135a and the well location was properly published as Section 8, Township 33 South, Range 12 West.

Wherefore, Griffin Management, LLC, prays that this Petition for Reconsideration be adopted by the Commission.

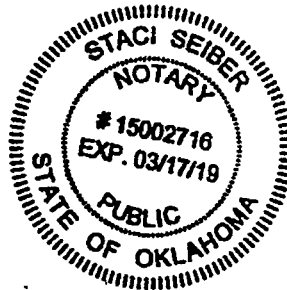
