# COMMISSION STAFF'S OUT-OF-TIME RESPONSE IN SUPPORT OF THE EMPIRE DISTRICT ELECTRIC COMPANY'S MOTION

- 1. On August 22, 2019, The Empire District Electric Company ("Liberty-Empire") notified the Commission it had decided to retire the Asbury coal plant ("Asbury") and expected the retirement to be no later than June, 2020. Pursuant to the unanimous settlement agreement in Docket No. 19-EPDE-223-RTS ("223 Docket"), Liberty-Empire indicated it would file an application with the Commission no later than February 5, 2020, setting forth the impact the retirement of Asbury would have on Liberty-Empire's Kansas revenue requirement ("February 5 Filing"). <sup>1</sup>
- 2. On January 21, 2020, Liberty-Empire, Staff and CURB met to discuss the retirement of Asbury, the acquisition of the Neosho Ridge, North Fork Ridge and Kings Point wind farms, and the February 5 Filing. Liberty-Empire, Staff and CURB agreed Liberty-Empire would file a motion with the Commission to make several requests regarding procedural matters. On February 5, 2020, Liberty-Empire filed its Motion.<sup>2</sup>
- 3. Staff has reviewed and supports Liberty-Empire's Motion. The procedural and accounting items discussed in the Motion establish an administratively efficient framework for evaluating, among other things, the retirement of Asbury and the acquisition of wind resources. Moreover, the Motion confirms the regulatory asset/liability provisions established in the 223 Docket. As such, Staff believes granting the Motion is reasonable and in the public interest.

4. Commission regulations require responsive pleadings be submitted within 10 days after service.<sup>3</sup> However, the Commission may waive its regulations if good cause is shown and if it is in the public interest do so.<sup>4</sup> The Motion submitted by Liberty-Empire sets forth a procedural framework to address significant items related to Liberty-Empire's cost of service. As such, it is critical the Commission be aware Staff is supportive of the Motion. For that reason, Staff asserts good cause exists and it is in the public interest to accept Staff's Response to Liberty-Empire's Motion.

WHEREFORE, the Staff requests the Commission issue an Order approving the Motion filed by Liberty-Empire on February 5, 2020.
