Pursuant to K.A.R. 82-3-135a(e), the above-referenced matter has been set for hearing. The hearing will be held on July 19, 2012, at 10:00 a.m., or as soon thereafter as the same may be reached, at the Kansas Corporation Commission, 130 S. Market, Room 2078, Wichita, Kansas 67202.

The hearing will be formal in nature and will involve both the rules of civil procedure and the rules of evidence. Please note that K.A.R. 82-1-228(d)(2) requires that corporations appear through an attorney. Pursuant to K.A.R. 82-1-229, Applicant must prefile their testimony by June 29, 2012, and Protestant(s) must prefile direct testimony by July 9, 2012. Commission Staff may prefile direct testimony by July 9, 2012. One original and seven copies of prefiled direct testimony must be filed with the Executive Director of the Commission, 130 South Market, Room 2078, Wichita, Kansas 67202. Rebuttal testimony may be presented at the hearing.

If any Party(s) fails to appear and participate at this hearing, the Commission may proceed to hear evidence against the Party(s) and enter such order as shall be justified by the evidence or may result in default judgment against the Respondent pursuant to K.S.A. 77-520.

Any person requiring special accommodations under The Americans With Disabilities Act needs to give notice to the Commission at least ten (10) days prior to the scheduled hearing date.
