#### ORDER CLOSING DOCKET

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having examined its files and records, and being fully advised in the premises, the Commission finds and concludes as follows:

- 1. On August 22, 2017, the Commission issued its *Order to Show Cause, Designating a Prehearing Officer, and Setting a Prehearing Conference*, setting a September 14, 2017, Prehearing Conference. The Prehearing Conference was continued various times throughout the proceeding, with the most recent Prehearing Conference being held on February 8, 2018.
- 2. On February 13, 2018, Commission Conservation Staff (Staff) filed a Motion to Close Docket, stating that the Operator has now plugged the well remaining on the Operator's license, and therefore, the Operator has resolved all the issues in this docket.<sup>2</sup>
- 3. Based on Staff's confirmation that the Operator has plugged the well remaining on the Operator's license, the Commission finds that all remaining issues in the docket have been resolved, and the docket should be closed.

#### THEREFORE, THE COMMISSION ORDERS:

A. This docket is closed.
