**PREHEARING OFFICER ORDER CLOSING DOCKET**

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having reviewed the pleadings and record, the Prehearing Officer makes the following findings:

1. On June 11, 2019, the Commission issued a *Penalty Order* against Great Plains Petroleum, Inc. (Operator) for one violation of K.A.R. 82-3-408 because the subject well was not in compliance with an injection permit and Operator failed to apply for a modification of the permit.<sup>1</sup>
2. On July 15, 2019, Operator requested a hearing.<sup>2</sup>
3. On October 17, 2019, Operator withdrew its request for a hearing.<sup>3</sup>
4. Based upon Operator's withdrawal of its request for hearing, the Prehearing Officer finds further proceedings are unnecessary.<sup>4</sup>

**THEREFORE, THE PREHEARING OFFICER ORDERS:**

This docket is closed.
