1. On June 11, 2019, the Commission issued a Penalty Order against Great Plains

Petroleum, Inc. (Operator) for one violation of K.A.R. 82-3-408 because the subject well was not in

compliance with an injection permit and Operator failed to apply for a modification of the permit.¹

- 2. On July 15, 2019, Operator requested a hearing.²
- 3. On October 17, 2019, Operator withdrew its request for a hearing.³
- 4. Based upon Operator's withdrawal of its request for hearing, the Prehearing Officer

finds further proceedings are unnecessary.⁴
