**EVERGY KANSAS CENTRAL AND EVERGY KANSAS METRO PETITION TO OPEN  
A NEW DOCKET FOR INTEGRATED RESOURCE PLAN (“IRP”) TRIENNIAL AND  
SUBSEQUENT ANNUAL COMPLIANCE FILINGS**

COMES NOW, Evergy Kansas Central, Inc. and Evergy Kansas South, Inc. (together as “Evergy Kansas Central”) and Evergy Metro, Inc. (“Evergy Kansas Metro”) (collectively referenced hereinafter as “Evergy”) and submits to the Kansas Corporation Commission (“Commission”) their *Petition to Open A New Docket for IRP Triennial and Subsequent Annual Compliance Filings* (“Petition”) and, in support, states as follows:

1. Evergy plans to file its 2024 Triennial IRP plan on or after April 1, 2024, in accordance with the IRP Process Framework set forth in the Commission’s Order Adopting Integrated Resource Plan and Capital Plan Framework filed on February 6, 2020, in Docket 19-KCPE-096-CPL.

2. Evergy wishes to establish a new docket for activities and documentation pertaining to the 2024 Triennial IRP filing and the two Annual Updates that follow in 2025 and 2026. To facilitate the sharing of confidential information among known parties and intervenors, Evergy requests that all parties to the 19-096 docket be automatically granted intervenor status in the new docket.

3. Evergy consulted with Commission Staff in advance of this filing, and Staff does not object to opening a new docket.

**WHEREFORE**, Evergy respectfully requests the Commission issue an order granting this  
Petition and opening a new docket as described.
