This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having examined its pleadings and records, the Commission concludes the following:

- 1. On July 17, 2022, Joseph A. LaFon filed a Formal Complaint against Totah Communications, Inc. (Totah), alleging that his landline phone would not ring when incoming calls were received over a 4+ year period. LaFon seeks a refund.
- 2. On July 21, 2022, the Commission determined that Mr. LaFon had established a prima facie case under K.A.R. 82-1-220(b).
- 3. On November 10, 2022, Totah and Commission Staff (Staff) filed an Unopposed Joint Motion to Dismiss, advising that Totah and Mr. LaFon have resolved the matter through settlement.¹
- 4. Since the parties have reached a settlement that resolves the Complaint, the Commission grants the Unopposed Joint Motion to Dismiss the Complaint.

THEREFORE, THE COMMISSION ORDERS:

- A. The Unopposed Joint Motion to Dismiss Complaint is granted.
- B. This Docket is closed.
