PRESIDING OFFICER ORDER SETTING PROCEDURAL SCHEDULE

The Presiding Officer rules as follows:

1. Terry E. Morris dba G L M Company (Operator) and Commission Staff both attended a November 6, 2020, status conference in this matter. Patrick Barney (Protester) failed to attend. Operator reported its intention to file a motion for a default order against Protester, which was filed November 10, 2020, and is now pending, but parties in attendance at the status conference also agreed to the following procedural schedule if Operator's motion is denied:

Operator's Pre-Filed Direct Testimony	Due: November 25, 2020
Protesters' Pre-Filed Direct Testimony	Due: December 11, 2020
Staff's Pre-Filed Direct & Rebuttal Testimony	Due: January 13, 2021
Operator & Protester Rebuttal Testimony	Due: January 20, 2021

Evidentiary Hearing before the Commission: **February 3, 2021, 9:00 a.m.**

2. If the Commission denies Operator's pending motion for a default order, then the above procedural schedule and below provisions shall govern this proceeding.

3. The evidentiary hearing shall take place via the Zoom videoconferencing platform. Log-in instructions shall be provided to parties as the hearing date approaches.

4. The evidentiary hearing shall be audio-streamed on the Commission's website.

5. Any party who fails to attend or participate in the evidentiary hearing may be held in default under the Kansas Administrative Procedure Act.¹

6. Failure to submit pre-filed testimony may result in the Commission restricting the right to testify and present evidence at the evidentiary hearing. At the hearing, the Commission may limit the parties' direct and rebuttal testimony to the pre-filed testimony.

7. Any person requiring special accommodations under the Americans with Disabilities Act should notify the Commission at least 10 days before the scheduled hearing date.
