ORDER APPROVING ADDITION OF WELLS AND EXTENSION OF FINAL DEADLINE

The Commission rules as follows:

- 1. On October 8, 2019, the Commission issued an Order Approving Compliance Agreement. The Compliance Agreement stated Operator had nine wells out of compliance with K.A.R. 82-3-111. Under the Compliance Agreement, Operator was to bring one well into compliance by November 1, 2019, and one additional well each three calendar months thereafter, resulting in annual quarterly deadlines of February 1, May 1, August 1, and November 1, with all wells being returned to compliance by November 1, 2021. The Compliance Agreement provides additional wells may be added with the written consent of the District Supervisor.
- 2. On August 20, 2021, Commission Staff filed a Status Update in this docket stating the District #2 Supervisor recommends amending the Compliance Agreement to include the German #5 well, API #15-113-01101 (Subject Well). Additionally, the Status Update states Operator is not opposed to the addition of the well to the Compliance Agreement. Further, with

the addition of the Subject Well, Staff recommended the final compliance deadline be extended to February 1, 2022.

3. Taking administrative notice of its records and upon reviewing Staff's Status Update, the Commission finds it appropriate to approve Staff's recommendation.

THEREFORE, THE COMMISSION ORDERS:

- A. The Subject Well is added to Operator's Compliance Agreement, and the final compliance deadline is extended to February 1, 2022.
 - B. All other deadlines in this matter remain unchanged.
