JOINT MOTION FOR PROCEDURAL ORDER

The Staff of the State Corporation Commission of the State of Kansas (Commission Staff or Staff), Wolf Creek Nuclear Operating Corporation (WCNOC), Evergy Metro, Inc. d/b/a Evergy Kansas Metro [f/k/a Kansas City Power & Light Company] (Evergy Kansas Metro), Evergy Kansas Central, Inc. [f/k/a Westar Energy, Inc.] and Evergy Kansas South, Inc. [f/k/a Kansas Gas and Electric Company] (collectively, Evergy Kansas Central), and Kansas Electric Power Cooperative, Inc. (KEPCo) (collectively, Joint Movants) hereby move the State Corporation Commission of the State of Kansas (Commission) for an Order establishing a procedural schedule in the above-captioned matter. In support of its motion, Joint Movants state the following:

1. On September 1, 2020, WCNOC, Evergy Kansas Metro, Evergy Kansas Central, and KEPCo jointly filed an application with the Commission for approval of its 2020 Wolf Creek Triennial Decommissioning Financing Plan.¹ On September 2, 2020, KEPCo filed an Attachment to the Joint Pleading.²

2. In Docket No. 163,561-U, the Commission mandated a decommissioning cost study be filed every three years, beginning September 1, 1993.³ In Docket No. 15-WCNE-093-

GIE, the Commission approved a Joint Status Report and Resolution, which set forth the format for and information to be included in following triennial filings.⁴

3. On September 11, 2020, the Citizens' Utility Ratepayer Board (CURB) filed a Petition to Intervene and Motion for a Protective Order and Discovery Order.⁵ The Commission subsequently granted CURB's Petition.⁶

4. On December 18, 2020, Commission Staff filed Direct Testimony regarding the Application.⁷ Staff's testimony was not opposed, disputed, or otherwise called into question by any party to this docket. The Joint Movants agree there are no contested issues. The Joint Movants have begun developing a Settlement Agreement concerning the matters discussed in the Application and Staff's filed Direct Testimony.

5. Joint Movants conferred to develop a procedural schedule for the remainder of this docket to propose to the Commission for consideration. That proposed schedule, as agreed to by the Joint Movants, is as follows:
