- 3. Westar Energy and FreeState have mutually agreed, subject to the Commission's approval, that as a matter of public convenience and to better serve a new customer, FreeState should serve as an electric public utility in the territory described in paragraph 1.
- 4. Westar Energy understands that FreeState has filed an application with the Commission to expand its electric service territory to include the territory described in paragraph 1.
