FOR MID-KANSAS ELECTRIC COMPANY, LLC**


COMES NOW Mark D. Calcara, an attorney in good standing, licensed to

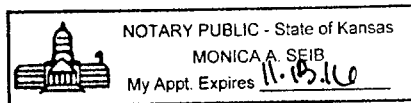


