ORDER SUSPENDING INTRASTATE MOTOR CARRIER OPERATIONS

The above-captioned matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and determination. Having examined its files and records, and being duly advised in the premises, the Commission finds and concludes as follows:

I. JURISDICTION AND BACKGROUND

1. Pursuant to K.A.R. 82-4-1b, 66-1,111, 66-1,112, 66-1,114, 66-1,114b and 66-1,115, the Commission is given full power, authority and jurisdiction to supervise and control motor carriers, as defined in K.A.R. 82-4-3f, doing business or procuring business in Kansas, and is empowered to do all things necessary and convenient for the exercise of such power, authority, and jurisdiction.

2. Pursuant to K.S.A. 2018 Supp. 66-1,129a, 66-1,130, and 66-1,142b, the Commission may suspend operations, revoke, or amend certificates, and initiate sanctions or fines against every motor carrier and every person who violates any provision of

Kansas law in regard to the regulation of such motor carriers and persons, or who fails to obey any order, decision, or regulation of the Commission.

3. Pursuant to K.S.A. 2018 Supp. 66-1,129(a)(7), the Commission has adopted motor carrier transportation regulations (K.A.R. 82-4-3g) consistent with the federal motor carrier safety assistance program and other federal requirements concerning transportation of hazardous waste.

II. FINDINGS OF FACTS

4. Savannah Traders LLC of Overland Park, Kansas (Respondent) is a motor carrier as defined in K.A.R. 82-4-3f, that operates commercial motor vehicle(s) in intrastate commerce.

5. Respondent operates under USDOT Number 2551471.

6. On May 2, 2019, Respondent was issued a penalty assessment of \$3,350 for violations of the Kansas Motor Carrier Safety Statutes, Rules and Regulations discovered during a compliance review conducted on April 15, 2019, by Kansas Corporation Commission Special Investigator(s) Wade Patterson. The Commission's Penalty Order is incorporated herein by reference and made a part of this Order.¹

7. The Penalty Order was mailed to Respondent via certified mail, return receipt requested, on May 2, 2019. A Proof of Service of the Penalty Order was filed in this docket on May 8, 2019, indicating the Respondent was served with the Penalty Order on May 4, 2019.²

8. On September 12, 2019, Commission Staff filed a Motion to Suspend Intrastate Motor Carrier Operations³ indicating the Respondent should be placed out-ofservice failure to pay the penalty amount of \$3,350. An Order Suspending Intrastate Motor Carrier⁴ was issued by this Commission on July 30, 2019.

9. Based upon a settlement agreement reached between Respondent and Transportation Staff, on September 17, 2019, this Commission approved Staff's Motion to Reinstate the Respondent's motor carrier operations⁵ and also approved the Stipulated Settlement Agreement.⁶ The agreement of the parties reduced the fine from \$3,350 to \$850, and the Order Approving Stipulated Settlement Agreement specifically stated that the \$850 fine was to be paid by Respondent within 30 days of issuance of the order.⁷

10. As of November 19, 2019, Commission records indicate Respondent has not complied with requirements of the Commission Orders stated above, as the fine of \$850 is currently unpaid.

III. CONCLUSIONS OF LAW

11. The Commission finds it has jurisdiction over Respondent as it is a motor carrier as defined in K.A.R. 82-4-3f.

12. The Commission finds Respondent received sufficient notice of the requirements of the Stipulated Settlement Agreement and the requirement to pay the fine pursuant to the agreed timeline outlined by the settlement.

13. The Commission finds Respondent failed to comply with the requirements of the Order Approving Settlement Agreement and therefore this Commission finds the

Respondent should be suspended from all intrastate motor carrier operations other than such motor carrier operations excepted from the Commission's regulation under K.S.A. 2018 Supp. 66-1,129, until such time as the carrier takes the necessary steps to become compliant.

14. The Commission finds Respondent is to attend a Commission-sponsored safety seminar within 90 days from the date of this Order, and it is to provide proof of attendance to Litigation Counsel.

THE COMMISSION THEREFORE ORDERS THAT:

A. Savannah Traders LLC of Overland Park, Kansas is immediately suspended from all intrastate commercial motor carrier operations other than such motor carrier operations excepted from the Commission's regulation under K.S.A. 2018 Supp. 66-1,129, until such time as Respondent pays the penalty amount of \$850 and brings its motor carrier operation into compliance with motor carrier safety statutes, rules and regulations. This Suspension of Intrastate Motor Carrier Operations Order may also attach and apply to the operations of successor entities, including any motor carrier entity or entities established or used to avoid the consequences of any Order to cease operations or suspending operating authority.

B. Savannah Traders LLC of Overland Park, Kansas is hereby ordered to attend a Commission-sponsored safety meeting within 90 days of the date of this Order, and to provide Litigation Counsel with written proof of attendance.

C. <u>Pursuant to K.S.A. 2018 Supp. 77-537 and K.S.A. 77-542, any party</u> <u>may request a hearing on the above issues by submitting a written request, setting</u> <u>forth the specific grounds upon which relief is sought, to the Executive Director, at</u>

1500 S.W. Arrowhead Road Topeka, Kansas 66604 within fifteen (15) days from the

date of service of this Order. Pursuant to K.S.A. 66-1,129a, hearings will be held within ten (10) days upon written request. Failure to timely request a hearing will result in a waiver of Respondent's right to a hearing, and this Order will become a Final Order against Respondent, suspending Respondent's motor carrier operations, ordering Respondent to attend a Commission-sponsored safety seminar within ninety (90) days of the date of this Order, and it is to provide Litigation Counsel with written proof of attendance.

D. Attorneys for all parties shall enter their appearances in Commission proceedings by giving their names and addresses for the record. For civil penalties exceeding \$500, a corporation shall appear before the Commission by its attorney, unless waived by the Commission for good cause shown and a determination that such waiver is in the public interest. K.S.A. 77-515(c); K.A.R. 82-1-228(d)(2); K.A.R. 82-1-202(a). For civil penalties of \$500 or less, a corporation may appear by a duly authorized representative of the corporation. K.S.A. 2018 Supp. 66-1,142b(e) and amendments thereto.

E. Failure to comply with the provisions of this Order may result in further sanctions to include, but not limited to, the assessment of civil penalties and/or the impoundment of commercial motor vehicles found operating in violation of this Order and any other remedies available to the Commission by law, without further notice.

F. The Commission retains jurisdiction over the subject matter and the parties for the purpose of entering such further orders, as necessary.
