## JOINT MOTION FOR PROCEDURAL SCHEDULE

Staff of the State Corporation Commission of the State of Kansas ("Staff"), the Citizens' Utility Ratepayer Board (CURB), Westar Energy, Inc. and Kansas Gas and Electric Company (referred to together herein as "Westar"), Kansas Industrial Consumers Group, Inc. (KIC) collectively referred to as "Joint Movants," and hereby move the Commission for an order establishing a procedural schedule. In support of their motion Joint Movants state as follows:

1. On March 4, 2019, Westar filed its Application for Recovery of Certain Costs through their Retail Electric Cost Adjustment (RECA) Tariff.<sup>1</sup>

2. On March 8, 2019, KIC filed a Petition to Intervene pursuant to K.S.A. 77-521 and K.A.R. 82-1-225.<sup>2</sup> In the Petition, KIC objected to Westar's request for an expedited 60 day review stating, the review period does not give enough time for KCC Staff and intervenors to fully review the Application and analyze the benefits or costs to customers.<sup>3</sup>

3. On March 13, 2019, CURB filed a Petition to Intervene pursuant to K.S.A. 77-521 and K.A.R. 82-1-225.
