APPLICATION OF FAIRPOINT CARRIER SERVICES, INC. AND ITS SUCCESSOR ENTITY CONSOLIDATED COMMUNICATIONS ENTERPRISE SERVICES, INC. TO CANCEL THE CERTIFICATE OF FAIRPOINT CARRIER SERVICES, INC.

COMES NOW FairPoint Carrier Services, Inc., and its successor entity, Consolidated Communications Enterprise Services, Inc.(CCES), by and through its attorney, Rachel Lipman Reiber, and hereby requests that as the result of its merger in Delaware into Consolidated Communications Enterprise Services, Inc. on December 31, 2018, that the certificate of FairPoint Carrier Services, Inc. be cancelled.

- 1. On February 8, 2000, FairPoint Communications Corp. filed an application to provide interexchange telecommunications services in Kansas. While the application was pending, FairPoint Communications Corp. notified the Commission that it had changed its name to FairPoint Communications Solutions Corp.
- On July 10, 2000, in Docket 00-PFCC-738-COC, the Commission granted a
 Certificate of Convenience and Authority to provide intrastate interexchange
 telecommunications services to FairPoint Communications Solutions Corp.

- 3. On March 20, 2003, FairPoint Communications Solutions Corporation filed an application requesting to change the company's name to FairPoint Carrier Services, Inc. This application was granted on June 4, 2003 in Docket No. 03-FPCC-780-CCN.
- 4. On December 31, 2018, as part of Consolidated Communications' organization chart reorganization, its subsidiary, FairPoint Carrier Services, Inc., a Delaware corporation, was merged into CCES, also a Delaware corporation. The Kansas Secretary of State was notified of this transaction on February 1, 2019 (Exhibit A).
- 5. Early in July 2019, Commission staff became aware that FairPoint Carrier Services, Inc., was no longer an entity registered to do business in the State of Kansas and notified CCES of this fact.
- 6. CCES currently holds certificates from the Commission to provide local exchange and exchange access services 16-EVMT-178-CCN, as well as interexchange and operator services within the State of Kansas, 15-COSC-219-CCN.
- 7. FairPoint Carrier Services, Inc.'s certificate is duplications of the entity into which it is merged, CCES. Hence, FairPoint Carrier Services, Inc., through its successor entity, CCES, now seeks to cancel its Certificate of Convenience and Authority.
- 8. All revenues for intrastate interexchange and operator services offered by CCES and what previously was known as FairPoint Carrier Services, Inc. will be reported through CCES for KUSF Year 23.

WHEREFORE, for all of the reasons stated above, FairPoint Carrier Services, Inc. and its successor entity, Consolidated Communications Enterprise Services, Inc. request that the entity formerly known as FairPoint Carrier Services, Inc. now be considered part of Consolidated

Communications Enterprise Services, Inc. and that the certificate of FairPoint Carrier Services, Inc. be cancelled.
