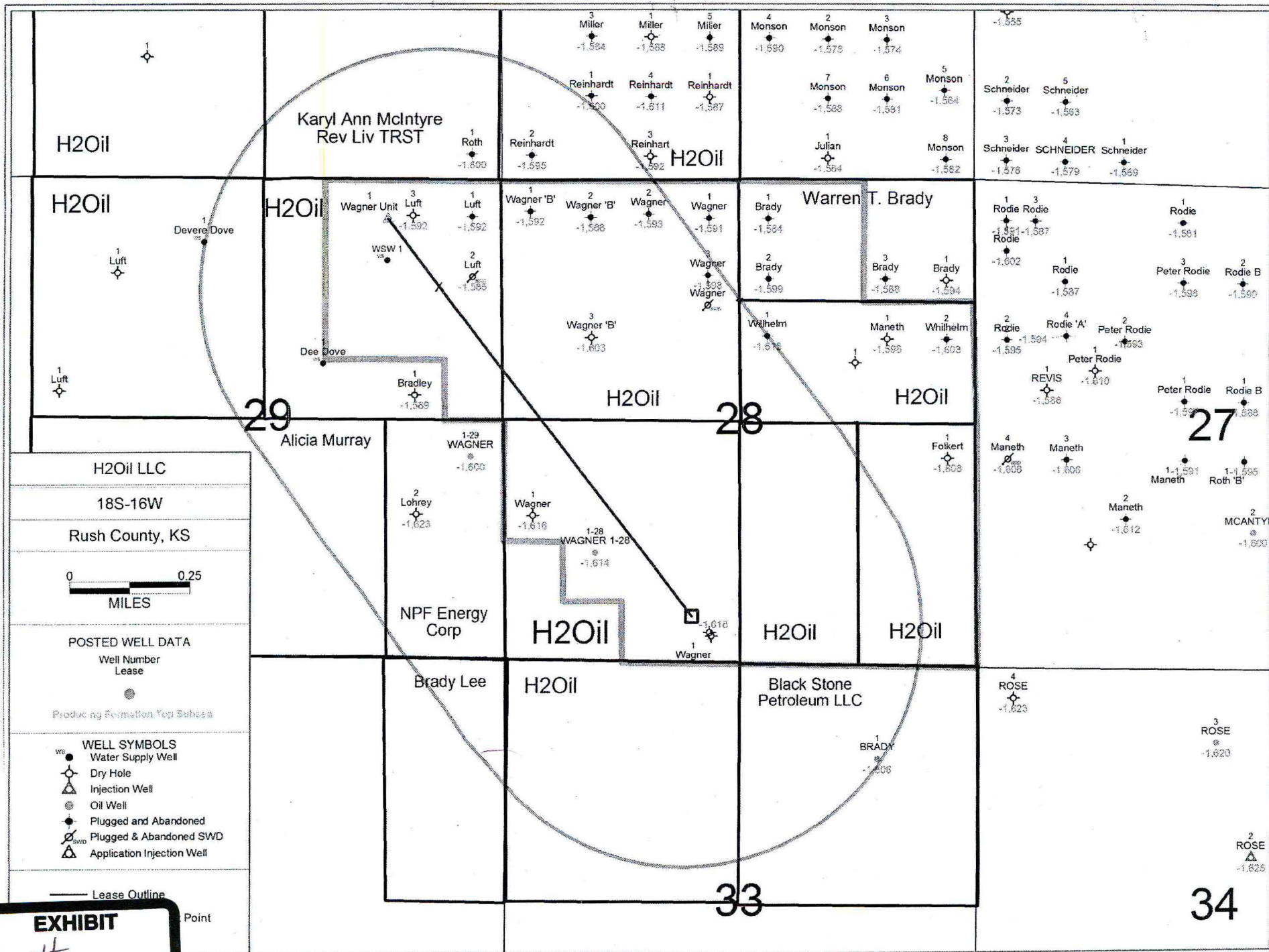
COMES NOW, Applicant H2Oil OPCO, LLC, 1400 Post Oak Blvd., Ste. 400, Houston, TX 77056.
Applicant herein and respectfully states as follows:

1. The Applicant is the owner of oil and gas leasehold interest in the subject acreage in Rush County, Kansas.
2. The Applicant seeks to complete the Wagner Unit #1 as a horizontally drilled well. The surface location is 410 feet from the North line and 1246 feet from the East line of Section 29-18S-16W, in Rush County, Kansas. The Wagner Unit #1 is planned to be an Injection well completed in the Reagan formation.
3. Attached and made a part hereof is Exhibit No. 1, plats showing the location for the Wagner Unit #1 in side and aerial view.
4. Attached and made a part hereof is Exhibit No. 2, a list of each operator or lessee of record (other than the Applicant) and each owner of record of the minerals in any unleased acreage within one-half mile radius of the planned well to be drilled.
5. That notice of the Application and opportunity for hearing thereon is being provided pursuant to K.A.R. 82-3-135a by mailing notice to those listed on Exhibit No. 2 and by causing the Notice of Pending Application to be published as required by the Commission in the Wichita Eagle and the Rush County News newspapers. Said notice provides that unless written protest is received by the commission within fifteen (15) days after the date of publication of said notice, the Applicant in this matter will be granted administrative approval after said 15 day period.

WHEREFORE, Applicant prays that this cause be docketed and in the event no protest is made to the Commission within the time period provided, an Order be entered permitting the drilling and completion of the Wagner Unit #1.
